From there, we can follow the progress of the bill, see which legislators on the committee for that bill, etc. From that site, we can also list those particular bills we want to follow and receive alerts on activity regarding that bill. We simply click on the tab that says MyTLO and list the bills you wish to follow.

Remember, we need to be in contact with our elected Representatives and Senators and let them know our thoughts about the bills that are before them. Republican Women are among the most informed citizens in our state. Our views are important. Just remember, when you are contacting your elected official, you are doing so as a private citizen. Do not refer to Montgomery County Republican Women or the Texas Federation of Republican Women in your communication because you are not speaking on behalf of those organizations.

Your Board of Directors has so much planned for the rest of the year and you will want to be a part of those plans. You can look forward to supporting the Pregnancy Assistance Center, God's Garage, and Camp Hope as we go through the year. In 2009, she accepted the position of Chief Deputy in the Montgomery County Tax Office and served in that capacity until being appointed to serve as Tax Assessor-Collector in 2014.

She was then elected to that position. She was re-elected to her second term last year. Tammy is an active member of the Tax Assessor-Collectors Association where she serves as President, chairs several committees, and represents the Property Tax Education Coalition Board.

General Meeting Minutes

MONTGOMERY COUNTY REPUBLICAN WOMEN RIVER PLANTATION GOLF CLUB MARCH 23, 2021



President Alice Melancon called the March 23, 2021, general meeting of the Montgomery County Republican Women to order at 11:35 a.m. Cindy Miller, Chaplain, led a prayer and pledges to the U. S. and Texas flags. Alice recognized attending elected officials and guests. The February general meeting minutes were approved as printed. The treasurer's report was approved and will be filed for financial review.

Alice gave a brief report on the March club activities. She spoke about the Wine and Chocolate Membership Social (March 1), the County Executive Committee's Steering Committee meeting attended by Alice and Suzanne Adams (March 2), the Board of Directors' meeting (March 11), the Nuts N Bolts workshop (March 16), and the Life and Liberty Event (March 19).

Alice then gave a short summery of bills proposed by the Texas Legislature concerning election integrity. House Bill 3229 would require a person who has applied for a mail in ballot to surrender the ballot if voting in person. HB 4369 would require the Ballot Board to maintain 6 years of signatures on file to verify signatures on mail in ballots. HB 4456 would require a pen and ink signature on mail in ballots and HB 2018 would require ballot propositions be written in plain language.

Amy Byers, Caring for America Chair, reported that the club donated 80 towels and 120 face cloths to Camp Hope. Amy has chosen the Pregnancy Assistance Center North as the club's next project. A brainstorming luncheon

will be held on March 29 at the home of Leanne Jaggers to discuss ideas on how the club can support the young mothers. Amy asked club members to start collecting baby items. Julia Morton, Finance Chair, gave a brief report for the Financial Review Committee. Julia, Suzanne Adams and Pearl Maggio met on February 25 and conducted a review of all checks and deposits for 2020. They found that everything was in order and made the recommendation that a log of voided checks be kept. Alice gave the Literacy Committee report. **Applications** for scholarships are now available. The club is awarding two \$1,000 scholarships to girls graduating in May. The deadline for returning scholarship applications is April 4.

Suzanne Adams reminded everyone to send their first quarter volunteer hours to Pearl Maggio.

Suzanne (1st Vice President,

Programs) introduced Robbi Hull, TFRW Vice President Legislation. Ms. Hull spoke on the basics of the Texas legislative She talked about process. Governor Abbott's leaislative priorities for the 2021 session: energy, education and election integrity. She went on to describe the steps a proposed bill must go through to become law: 1) the bill is introduced, 2) the bill goes to the Committee Action Committee and Calendars Committee, 3) the bill moves to floor action, 4) if the bill passes by a majority vote, it moves on to the other house, 5) if the other house has a similar bill, it goes to the Conference Committee,

6) the bill goes to the Governor's desk where it is signed into law, not signed into law, vetoed or undergoes line item.

Ms. Hull recommended using

Texas Legislature Online – Capitol.TX.gov as a resource for information on proposed bills. The federal resource for legislation is Congress. gov. Ms. Hull can be contacted at V.P. Legislation@ TFRW.org.

Barbara Eddleman, 2nd Vice President Membership, reported a club membership of 94 members and 38 associate members. Kim Bailey, Yearbook Chair, will email digital copies of the 2021 Yearbook by the end of March. Printed copies can be purchased for \$5, contact Kim to buy one.

UNFINISHED BUSINESS:

Members were asked to visit the committee orientation and browse the posters that displayed the work of the various MCRW committees. Fish Creek Republican Women asked to borrow the posters to display at one of their meetings.

NEW BUSINESS:

-There will be a fundraiser in the fall, probably in October. Details to follow. -Emails will be sent to encourage members to contact elected officials on important legislation. -A C.H.A.T. is being planned with details to follow.

UPCOMING BILLS IN THE TEXAS LEGISLATURE



Several bills have been proposed in the some of the areas that TFRW has chosen as important this session. These areas include: election integrity and education. Also an important area this session is concealed carry rights.

There are two excellent websites where you can follow the pertinent bills. The first is Texas Legislature Online (https://capitol.texas.gov). The second is LegiScan (https://legiscan.com>TX). If you know the bill number (for example, HB 6 concerning election integrity), you can enter that to get the status, hearing dates, and authors and co-authors of the bill. The website also lists the members of the Texas Legislature with their contact information. You can also enter the subject matter (for instance, election integrity, education, concealed carry, or any other topic in which you have an

interest), and all the relative bills are shown.

Please remember - if you are contacting a senator or representative by phone, email, or letter - be courteous and respectful. Make your points calmly and factually-based. Hearing from constituents, whether from their party or not, can make a huge impact on the legislator's vote. And you may always contact legislators other than your own.




